Supplemental Narrative

On 1/25/16 at approx. 1344 hrs, I Service Officer Hernandez was working dispatch when a call came in on a regular business line from . . . stated that while viewing his home security remotely, he saw a black male adult wearing a blue shirt in his courtyard, and that he did not know who it was, and believed the subject may be attempting to burglarize his home. After provided all the pertinent information regarding the subject, I advised him that the units would be immediately dispatched and the call was terminated. During the course of the incident, called back three additional times, one to report that packages may have been stolen approximately six days prior, and then to report that a male adult in a blue uniform was currently in his courtyard, and lastly to request thru S.O. Albao that he be contacted with the disposition of the call. contact information was then provided to Sgt. Barber via text on the W/C's department issued phone.

All contact with . . . was professional, and nothing unusual transpired during any of the subsequent phone calls.
