Miscellaneous Report

On 04/18/16, at approximately 2010 hours, I, Cpl. Blitz (#710), responded to Paseo Del Mar regarding a Barking Dog complaint call reported by RP/ . Upon my arrival, at approximately 2014 hours, I verified that a dog located in the side yard was continually barking. After completing and leaving a copy of an Animal Disturbance Notice in the mailbox of Paseo Del Mar, I telephoned RP/ as requested and left a recorded message of my enforcement action under Incident #184522.

At approximately 0430 hours, I was advised by PVEPD dispatch to recall RP/ after I had completed the towing of a vehicle following a traffic stop. At approximately 0510 hours, I spoke with by phone in order to discuss his barking dog complaint. After doing so, indicated that he was satisfied in how the matter was handled. then inquired about the recent arrest of a transient in the North Plaza and praised Sgt. Lebeau and his officers for taking the appropriate action. As I began to conclude my conversation with , he stated that he wanted to discuss one last topic. brought up the parking and noise issues near his residence. requested that I notify Chief Kepley that with the coming summer months, he would be leaving his windows open during the early morning hours. In doing so, he anticipated that he would be able to hear subjects associated with their illegally parked vehicles. stated that I was to inform Chief Kepley of the following: If he did not direct police personnel to cite all illegally parked vehicles, a number of residents would consider filing a class action lawsuit against him and the city. I advised that I would convey his message to Chief Kepley.
