On 06/16/13, I (Ofc. Bertocchini #741) was working uniformed patrol in marked black and white patrol car #723. At approximately 1232 hours, I was dispatched to Horcada Place regarding a neighbor dispute.

Upon my arrival, I was given the following information from Ofc. Shea #738: At approximately 1130 hours, Ofc. Shea was dispatched to Horcada Place regarding a construction noise complaint. Upon his arrival, he met and spoke to the resident . had a commercial contractor inside of his residence who was using tools that produced an audible noise. Ofc. Shea advised Ajar that the commercial construction inside of the residence needed to cease and only non-commercial work was allowed on Sunday.

I met with who related the following: On the above date and time, he was using his electric leaf blower to clear dirt from his driveway. He was contacted by Ofc. Shea who informed him that the commercial construction needed to cease but that he could continue his own non-commercial work. stated that he stopped the commercial construction and did not continue to use the leaf blower immediately, but instead went inside of his residence to get a drink. Shortly thereafter, continued to clear his driveway using the leaf blower. He then witnessed a female (NFD) on the north end of this property hanging over the fence and taking a video of him. took out his camera phone and began to record her doing this until she quickly retreated. The video also recorded neighbor, with the female. stated that began to yell at him the following phrases: "You fucking asshole!", "You fucking prick!" and "You've already been warned!" stated that then began to walk on the city owned easement between their property lines with his chest "puffed" up. felt that this was a threat to his well being and an attempt to initiate a physical altercation between them.

also noted that he has five "No Trespassing" signs posted on the perimeter of his property. See attached photographs. I also requested a copy of the video spoke of which he emailed to me.

I advised that no leaf blowers are allowed to be used in PVE on Sunday's, whether commercial or personal use.

Several unsuccessful attempts were made to contact and the female who was with him. At approximately 1600 hours, I received a phone call from who stated that he only wanted to know how the leaf blower situation was resolved with his neighbor. He refused to answer any questions regarding the above incident over the phone but stated that I could e-mail any questions to him.

The female involved was not officially identified, but may be the RP for the earlier call at this location listed as : (She advised her address was Paseo Del Mar, 's address.
